Dog-days continue.

"Dog Days"- July 3rd to 11th August. Sirius, the Dog Star, rises in the morning sky at about the same time as the Sun. The Romans believed this added to the heat of the Sun giving the hottest days of summer.

The future of the local affordable housing scheme was the subject of a recent meeting of Sevenhampton Parish Council with representatives from Cotswold District Council and the Gloucestershire Housing Association.

Funding for the scheme as originally proposed has been turned down. Because of the high standard of the build necessary due to the location the cost would be in the region of £100K per unit. It was suggested that there should be a mix of rent and low cost home ownership to help fund the project - this was considered to be more in line with the original concept of the scheme. The eligibility of applicants would be restricted to current residents, past residents, those employed locally or people with close family ties (including those sharing existing households and classed as single people for housing needs).

Although there are 99 names on the latest list of applicants, CDC/GHA were only

really interested in those within the Gold and Silver bands of housing need. There are 1 Gold (single) and 1 adult + 1 relative, 3 couples without children, two single people and 10 families with children in the Silver band.

The Parish Council's main concern is whether low cost ownership would be affordable as GHA would be looking at anything between 25 and 75% share. Government policy stated that in settlements under 3000 there should be an 80% equity share per house. The rental aspect would therefore be very high. Also the CDC Local Plan, currently in the amendment stage, includes a policy that no new building would be allowed in rural locations for the foresee-able future.

The Parish Council later decided that, because of the changed nature of the scheme, it would be necessary to undertake an updated Housing Needs Survey. The previous one was completed in 2002.

# **Annual Parish Council Meeting**

This was held in the Village Hall On Wednesday 24th May with all the Parish Council there except for Bill Jenkin.

The meeting re-elected Lesley Ball & Bill to the roles of Chair & Vice Chair respectively. Bill would also continue to represent the PC on the Hall Committee.

Affordable Housing was discussed as there had been a sub-committee meeting with Martin Hutchings of Cotswold District Council and Mike Edwards of Gloucestershire Housing Association (see above). It was agreed that a further Housing Needs survey be undertaken.

The plethora of rumours surrounding Wind Turbines were discussed and it was decided that no further action would be worthwhile until a planning application had been made. On behalf of the PC, Annie Weatherley, the Parish Clerk, has requested that CDC inform her immediately if any such application is made.

Parking at Chapel Cottages was discussed but after an approach from Fosseway Housing it seems that none of the current owners or tenants was keen on an alteration to the current arrangements.

Other items raised were planning applications, the award of the grass-cutting contract and the reasonably healthy state of the PC finances.

RUPPS & BOATS were aired but if you've forgotten what they are, more on the back page!

# NEW LEGISLATION ON MOTORISED VEHICLES' ACCESS TO GREEN LANES RUPPS, BOATS & RBs again

The Natural Environment & Rural Communities (NERC) Bill has completed its passage through Parliament and received Royal Assent on 30 March. Part 6 of the Bill was intended by the Government to close the loophole whereby unsurfaced tracks could become Byways Open to All Traffic (BOATs) for the use of motorised vehicles on the basis of historic use by horse and cart. However, as first drafted, this legislation would have been totally ineffective as all existing claims for new BOATs would have been exempt and a year's grace would have been allowed after the Bill became law, so allowing even more claims. The prospect of impending legislation had caused a huge upsurge in BOAT claims all over the country including the two RUPPS in our own parish.

In the Spring of 2005 an informal coalition of organisations (including CPRE) was formed, called the Green Lanes Protection Group (GLPG), with the general aim of protecting the countryside from unsustainable recreational use by motor vehicles and the specific objective of trying to achieve the effective enactment of the NERC Bill. Thanks to the sustained and meticulous hard work of a few dedicated people negotiating on its behalf, the GLPG has achieved astounding successes which would have seemed impossible at the outset.

Only those claims for new BOATs lodged before 20 January 2005 will now be exempt from the new legislation, apart from very limited exceptions (the two claims in our parish were made after that date).

There are technical provisions protecting vehicular rights over what may be regarded as 'ordinary' (minor) roads. Otherwise all RUPPs (Roads Used as Public Paths) will become Restricted Byways on which it will be an offence to drive a motorised vehicle. There are special provisions covering cases where properties are accessed by RUPPs.
